Afghan Coalition's (AC) bilingual/bicultural staff and volunteers will serve as liaisons that bridge the language and cultural gap between providers and clients, and increase access to clients to the services and resources of the local community. The AC is respectfully requesting \$25,000 to serve 400 unduplicated adults, families and children by providing linkages to Social Services, translation services, information and assistance, and crisis intervention and assistance.

Fremont houses the largest Afghan community in the U.S. From 1980 through 2004, nearly 50,000 people from Afghanistan entered the United States as official refugees or asylees (Office of Immigration Statistics, 2006). The largest Afghan community in the US settled in the N. California area, centered in the City of Fremont. This community, suffers from language barriers, illiteracy, physical and mental health issues related to war trauma, as well as, immigration-related stressors, loss of

social networks, difficulty accessing health and human services, unemployment and poverty.

The Afghan Coalition will provide the following services:

- 1) Crisis Intervention/Assistance: AC will assist other social service agencies in dealing with crises involving Afghan clients. These cases often involve obtaining food, shelter, clothing and financial assistance.
- 2) Cultural Counseling & Women's Support Groups: AC will provide peer counseling and limited casework on issues such as immigration, and cultural adjustment. AC also holds weekly women's support groups, which are delivered in conjunction with an entrepreneurial training program for women (microenterprise). The group discusses health and family issues and provides support to each other in working toward self-sufficiency.
- 3) Health Education: AC will provide health education activities in the form of community workshops involving presentations to Afghan women and youth groups, and special activities such as health fairs.
- 4) Referrals & Translation: The AC will link and guide constituents to appropriate social services by providing referrals, translation, and assistance with completion of appropriate applications.
- 5) Community Services: Community members will participate in community-building activities/events reducing isolation.
- 6) Youth Enrichment Activities: The AC will link Afghan youth to facilities and groups that promote access to assistance with academic improvement, leadership opportunities, and encourage healthy lifestyle choices.

1. PROPOSED PROGRAM: Based on the Impact Categories for the RFP please describe the community need your agency is proposing to address.

Afghan Coalition's Social Service's Program: Connecting Refugee Communities to Social Service Resources will address the following impact categories:

- -Crises Intervention Services: The Afghan Coalition is one of few agencies that serves Afghan and other near-eastern domestic violence survivors who are in immediate need of shelter, safety, and fiscal assistance. The Afghan Coalition also assists individuals who are living with extended family and are forced to leave suddenly. Other community needs that are relevant to this category are those who are struggling with drug and alcohol abuse and need immediate connection to rehabilitative services because they are in danger of losing their jobs, housing, and families.
- -Basic Needs Services: Afghan Coalition staff frequently encounters clients who have immigrated to the United States as refugees, asylees, or by other forceful circumstances. These individuals require immediate assistance finding shelter, applying for monetary support, acquiring health and mental healthcare and securing nourishment.
- -Strengthening Services: The Afghan Coalition believes in building the self-sufficiency and independence of its clients. Through this impact area, the Afghan Coalition hopes to create opportunities for assimilation, build job-training and skills, and reduce isolation barriers that cause further distress.

2. Please provide us with evidence of need for the program you are proposing.

Fremont houses the largest Afghan community in the United States. Since 1981, Afghans have been the world's single largest refugee population each year, accounting for at least a quarter of all refugees. Up to 30,000 Afghan refugees may live in the S. F. Bay Area, not including native born children (Lindgren & Lipson, 2004; Robson, Lipson, Younos, & Mehdi, 2002; Yollin, 2002). Afghan refugees arrived in Fremont, California, and the larger San Francisco Bay Area in two primary immigration waves. A steady influx arrived from 1980 to 1993 and a second wave occurred from the late 1990s to the present time. The second group of newcomers included large numbers of people from rural areas, who often had little or no formal education. Widows have also comprised a large part of this second immigration wave since 1999, when they were classified by the United Nations High Commissioner for Refugees (UNHCR) as "Women-At-Risk" (Robson, Lipson et al., 2002).

The refugee experience brings with it the traumas of violent experiences in wars and resulting post-traumatic stress disorders exacerbating domestic violence. Complicating matters, problems in the community are often hard to pinpoint because of what is known as the Afghans' culture of "silence and secrecy." The largest Afghan community in the United States settled in the Northern California area, centered in the city of Fremont. This community, suffers from language barriers, illiteracy, physical and mental health issues related to war trauma, as well as, immigration-related stressors, loss of social networks, difficulty accessing health and human services, unemployment and poverty. Mental health problems are often expressed as somatic complaints, such as headaches and muscular-skeletal problems, and have been shown to exacerbate chronic health conditions such as heart disease, stroke and diabetes. Recent arrivals also present with a host of unique problems. These individuals have also endured post-9/11 warfare in Afghanistan or long stays in Pakistani or Iranian refugee camps. In addition to these barriers inhibiting assimilation and resettlement, many families are experiencing culture shock in the form of parent-

child conflicts, and family stress due to generational differences between the youth raised here and the parents traditions.

3. In order to address the community need you stated above what are the activities your agency is proposing to conduct.

The Afghan Coalition will provide the following services:

- 1) Crisis Intervention/Assistance: AC will assist other social service agencies in dealing with crises involving Afghan clients. These cases often involve obtaining food, shelter, clothing and financial assistance.
- 2) Cultural Counseling & Women's Support Groups: AC will provide peer counseling and limited casework on issues such as immigration, and cultural adjustment. AC also holds weekly women's support groups, which are delivered in conjunction with an entrepreneurial training program for women (microenterprise). The group discusses health and family issues and provides support to each other in working toward self-sufficiency.
- 3) Health Education: AC will provide health education activities in the form of community workshops involving presentations to Afghan women and youth groups, and special activities such as health fairs.
- 4) Referrals & Translation: The AC will link and guide constituents to appropriate social services by providing referrals, translation, and assistance with completion of appropriate applications.
- 5) Community Services: Community members will participate in community-building activities/events reducing isolation.
- 6) Youth Enrichment Activities: The AC will link Afghan youth to facilities and groups that promote access to assistance with academic improvement, leadership opportunities, and encourage healthy lifestyle choices.

The Afghan Coalition operates from 9am-4pm, services are located in Fremont's Family Resource Center.

5. Please describe your target population and the projected number of clients to be served.

Afghan Coalition's (AC) bilingual/bicultural staff and volunteers will serve as liaisons that bridge the language and cultural gap between providers and clients, and increase access to clients to the services and resources of the local community. The AC is respectfully requesting \$25,000 to serve 400 low-moderate income unduplicated adults, families and children by providing linkages to Social Services, translation services, information and assistance, and crisis intervention and assistance. It is estimated that approximately 224,922 Afghans live in Fremont, CA with a 21.6% rate living below poverty level (City-Data.com). The population that the Afghan Coalition serves are primarily English-Language Learners, immigrants from rural areas of Afghanistan, who often had little or no formal education. Widows have also comprised a large part of this demographic.

10. What is your client database and how will it help you measure your proposed program results and outcomes? If you do not have a database, how do you propose to track client outcomes if this program is funded?

The Afghan Coalition uses a customized database for every client encounter, documenting the service delivery. Custom fields in the database include capturing household income, female head of household, gender, age, ethnicity, amount of time in the United States, marital status, reason for visit, referral source, to whom we refer clients, type of services provided, client service notes, and hours of service delivered for each client. The database aggregates all of the entered information into easy to read reports that also provides the number of clients served.

Describe client involvement or input in your evaluation process.

Program evaluation is an important component of our work at the Afghan Coalition. Every July, our team contacts clients to complete surveys that inform our program. These surveys ask regarding the quality of services received by the clients, rate the staff and program components, request information regarding engagement, and request input regarding improvement and usefulness of programs. Many of our projects have their own evaluation's that are conducted in the form of pre-post surveys -- these projects include Breast Health, and the Afghan Mental Health Project.

12. ORGANIZATIONAL CAPACITY: Provide us with a brief history of your organization, including years providing services to the community.

The mission of the Afghan Coalition is to empower refugee families, women and youth, both locally and in Afghanistan and to build bridges between the United States and Afghanistan. The mission is accomplished through the provision of community services, supporting member organizations', and community based programs. Since 1996, the Afghan Coalition has provided the largest center of support for Afghan refugees and other immigrants having difficulty adjusting in the United States. Serving over 1,000 community members per year, particularly immigrant women and children, bilingual/bicultural advocates bridge the language and cultural gaps between community members and financial and social services. This support

provides Afghan families unparalleled access to community resources such as social benefits including the Earned Income Tax Credit, health services and translation support, language classes, parenting information, education and social networks. We foster self-esteem, motivation, hope and community service so that our program participants can become self-sufficient contributing members of society. Although the Afghan Coalition's primary service population is the Afghan community, the agency's multilingual capacity makes it possible to serve Pakistani, Arab, Indian and Iranian immigrants as well.

The Afghan Coalition is located in the Fremont Family Resource Center, where bilingual/bicultural staff and volunteers work to empower underserved and vulnerable Afghan families, women and youth living in Alameda County.

20. Using your budget as a reference, please describe how you intend to leverage City of Fremont funding for this program with other sources such as county, state, federal, foundation and other cities.

The City of Fremont Social Service funding will be leveraged by using Alameda County PEI funding, and the Women's Breast Health Project and Men's Screening Project to cover the cost (or portions) of the Health Navigator/Domestic Violence Specialist. The Micro-Enterprise womens groups are also leveraged with other funding. All other personnel and operating costs assciated with these social services are also leveraged by the other grantors listed in the provided budget.

21. COMMUNITY ENGAGEMENT: Describe efforts to serve culturally and linguistically diverse clients or to serve a traditionally underserved population.

Located in the Fremont Family Resource Center, the Afghan Coalition's bilingual/biculturalstaff bridge the language and cultural gaps between community members and health and social services. This support provides Afghan families and other immigrant individuals and families unparalleled access to community resources such as social benefits, health services and translation support, language classes, parenting information, education and social networks. When families are referred for case management services, the case works assesses the family's immediate and underlying needs, develops with the family a strength-based family case treatment plan, locates viable resources and services, assists in connecting family members to appropriate services, identifies barriers to use of services, advocates for the youth/family when appropriate, and monitors progress as needed. When other agencies need support serving Afghans, due to language or cultural barriers, the Afghan Coalition staff provides critical translation, cultural counseling, information and referral, case management, crisis intervention, support groups, advocacy and education. We track ethnicity information using our web-based database, which is utilized by all direct service staff.

22. Who are the critical partners your organization engages with or are planning to engage with to increase the effectiveness of your proposed program? Please describe the contribution each partner will make.

The Afghan Coalition collaborates extensively with other service providers located at the Fremont Family Resource Center, such as the Social Services office, EDD, Rehab Program, City Serve, East Bay Agency for Children, Family Resource Center, and others. The Afghan Coalition also works with six other Mental Health Afghan agency sub-contractors in the Fremont area, as well as County Mental Health Providers. The Afghan Coalition Breast Health project also works with community and county health clinics in the Fremont area. The Afghan Coalition often serves as a liaison between Afghan clients and other county, city and nonprofit service providers. The Afghan Coalition collaborates with other agencies by serving as a resource for the integration of Afghan families into community activities and events. The Afghan Coalition has developed successful association partnerships to deliver direct services, make cross-referrals, convene community dialogue on access and cultural competency issues, conduct educational workshops and events and conduct community needs assessments. The Afghan Coalition also has maintained a working relations with professors at CSU East Bay who are interested in conducting community research related to Afghan community issues and needs.

The Coalition makes extensive use of volunteers in all of its programs, resulting in extremely cost-effective services, which allows us to meet program outcomes. Community members help the Afghan Coalition to plan and implement special projects such as cultural shows, and holiday celebrations. They also assist by providing translation and client transportation services after they have been trained in all confidentiality and other policies.

Describe your organizational structure, including information about your Board of Directors involvement in the program and any financial oversight they may have. Describe any local resident or client involvement on the board.

The Afghan Coalition's Board of Directors oversees the mission, strategic vision, financial affairs, establish overall policy for agency operations, set priority directions and programs, and supervise the performance of Executive Director. The Board also maintains a working committee structure that includes the Executive Committee, Marketing and Resource Development Committee; Community Involvement & Volunteer Committee; and Program Committee. The full Board of Directors meets every two months, the working committees meet every month, and the Executive Committee is authorized to meet as needed to conduct time sensitive business, with full Board review and approval at next scheduled Board meeting. The majority of Board members reside in the city of Fremont and adjacent cities. They are familiar with the needs and issues experienced by the Afghan community. Local residents and clients are being recruited to participate in the Board working committees, as a training opportunity before being invited or applying for Board of Director membership. Executive Director $-\$60,000 \times 0.063 \%$ fte =\$3,782

Responsible for contract compliance; supervision of project management 5% admin; reports to Board of Directors. Other funding for this position is provided from Alameda County University of Calif. Breast Health grant and some foundation funding. The Executive Director also provides direct services to clients when other staff is not available 10% direct.

Domestic Violence Specialist - \$39,864 x 0.1277 % fte =\$5,091

The Domestic Violence Specialist assists clients by addressing health and mental health and social service needs through one-on-one and case management services. Provides service advocacy refer to other needed services and often serves as liaison and interpreter with other service providers. Other funding is provided by Alameda County and some

foundations.

Fringe Benefit/PR Taxes - \$ 51,488 x 0.04754 % fte =\$2,570

Payroll Taxes/Fringe Benefits rate is 29% of gross salaries and consists of Payroll Taxes of 10% of gross salaries of 17700 or 1770 (FICA-ER SUI Stat ETT & Workers Comp Ins). Fringe Benefits are 19% of gross salaries of 17700 or 3363 and includes medical insurance and pension. Other funding is provided by Alameda County and some foundations.

Other individuals that express interest in participating in our programs include South East Asian and Asian clients. Over 98% of our clients are Afghan.

Table C lists two staff members available to assist with domestic violence intervention: Seema Faizi and Rona Popal are both trained and certified domestic violence advocates.

The Afghan Coalition is currently working with a grants specialist diligently pursuing additional funding to support and expand our much needed Social Service work.

The Afghan Coalition's vital community services promotes the health and well being for Afghans/Afghan Americans and other

Farsi speaking cultures living in Southern Alameda County (primarily Fremont). Afghans have tremendous barriers to accessing social services for themselves and their families because of lack of bilingual/bicultural staff in local social service agencies, unfamiliarity with what different social service agencies can offer, and difficulty adjusting to unfamiliar models of service delivery. The Coalition is located in the Fremont Resource Center, where bilingual/bicultural liaisons bridge the language and cultural gap between our clients and social service providers, giving Afghan families and youth critical access to community resources. The Afghan Coalition provides clients with direct social services including, business training (microenterprise), case management, cultural counseling, crisis intervention, domestic violence prevention, women's support groups, translation, information and referrals for housing, health and other social services as well as mental health and Afghan women's breast health projects. A youth leadership, soccer program and cultural activities are also promoted as a part of our service. Between 619 and 1000 community members (1000-1500 client visits) are served annually. The Afghan Coalition's Social Services program offers vital community services that promote the health and well-being for Afghans/Afghan Americans and other Farsi speaking cultures living in Southern Alameda County (primarily Fremont). Afghans face tremendous barriers to accessing social services for themselves and their families for the following reasons; a lack of bilingual/bicultural staff in local social service agencies, unfamiliarity with what different social service agencies can offer, difficulty adjusting to unfamiliar models of service delivery, general misunderstanding and fear of government agencies. The Coalition is located in the Fremont Resource Center, where bilingual/bicultural liaisons bridge the language and cultural gap between our clients and social service providers, giving Afghan families and youth critical access to community resources. The Afghan Coalition provides clients with direct social services including, business training (microenterprise), case management, cultural counseling, crisis intervention, domestic violence prevention, women's support groups, translation, information and referrals for housing, health and other social services as well as mental health projects. Cultural and health education activities are also promoted as a part of our service. Additionally the Afghan Coalition promotes the future of the Afghan Community through advocacy and encouraging our community members to have an active voice in City Council meetings. The Afghan Coalition provides wrap around services by assessing each client in one-on-one meetings with Health Advocates. During these meetings clients are provided with information about the organization and referral partners. Between 619 and 1000 community members (1000-1500 client visits) are served annually. The Afghan Coalition addresses the needs of the refugee population. The Afghan Coalition program programs include: crisis intervention, cultural counseling, assistance to domestic abuse victims, linkage to social services, information and referral, advocacy, health education and parenting workshops, and support groups and empowerment workshops for women. The objectives of the project are increased access to public and private services and resources, improve the ability of women and girls to deal with critical family issues and escape domestic abuse, and build a sense of pride in the community.

The program will serve 255-300 unduplicated individuals. The clients will receive at least one hour of assistance or will participate in group or workshop lasting at least one hour. Clients will be linked to social services, translation and informational assistance. Counseling and Crisis Intervention for victims of domestic violence will be provided by a Domestic Violence Specialist. Women, Senior Men and parent education workshops will be provided on a on-going basis. Additionally, the Afghan Coalition will provided special projects and events for the targeted population.

These services benefit low/moderate income clients by assisting the clients with face to face interpreters that can help them understand and fill out forms, navigate the US systems and provide cultural counseling reducing their stress and anxiety as they adjust to their new lives. Additionally, those suffering from domestic violence are able to be linked to resources that they may not be aware of or have the means to access on their own. Clients are educated on the types of domestic violence, how to make a safety plan, and linked to appropriate resources. The classes are taught using a culturally sensitive curriculum. Lastly, the special projects and events give the community a sense of pride and ownership by coming together, sharing stories, and reducing feelings of isolation.
